

GOOD TO KNOW WHEN RENTING A HIKER'S CABIN

Stay

You are welcome in the accommodation from 2 p.m. on the day of arrival and must leave before 10 a.m. on the day of departure. Smoking is forbidden in our accommodations and pets are not allowed. The maximum number of people in the accommodation is as much as there are sleeping places. An exception can be made for babies in consultation with the reception.

There is no water in the accommodation and there are no sanitary facilities. For this you can go to the nearby sanitary building.

Linen and bedding

It is possible to rent bed linen from us (excluding towels and tea towels) for € 10,00 p.p. You must mention the rental of linen when booking. Duvets and pillows are provided. If you choose to bring your own bed linen, please take into account:

- 1- persons fitted sheet / pillowcase
- 1- persons duvet cover
- Towel and tea towel

Upon departure, you must remove the rented bed linen from the beds.

Night's rest

Due to the night's rest, the incoming barrier is closed between 23 pm and 07 am. In an emergency you can reach us at 0511 - 431660.

Cancel

Cancellations are done according to the Recron conditions. We recommend that you take out cancellation insurance. The premium is 5.5% of the total amount + € 3.50 costs.

Payment

The first payment (50% of the total amount) must be made within 8 days after receipt of the booking confirmation. The remainder must be paid before arrival. We charge € 7,50 reservation costs.

Deposit

The deposit when renting a hiker's cabin is € 100,00. If the accommodation is left clean and without damage, you will receive the deposit by bank transfer within 10 days.

Cleaning costs

Cleaning costs are required. The costs for this are € 25,00.

Visitors

If you expect a visit, you must report this at the reception. Visitors' cars may not be parked on the campsite. These must be parked in the car park outside the campsite. A visitor rate of € 1,00 p.p.p.d. applies for visits.

Other

It is not allowed to place extra tents at the accommodations. In case of damage or malfunctions, we request that you report this immediately at the reception. We will respond to this as soon as possible. You must always follow the instructions of the personnel. The management is always entitled to refuse unauthorized access to the site and to deny persons who misbehave access to the campsite. Familiecamping De Kleine Wielen is not liable for damage and / or injury arising as a result of your stay on the site, as well as for damage incurred through the use of the facilities / facilities present on the site. Familiecamping De Kleine Wielen is not liable for damage claims arising from noise or odor nuisance and any external calamity, as well as the terrain as a result of weather influences. Furthermore, no liability is accepted for the breakdown and / or non-use of the available facilities / facilities. Everyone stays at their own risk.
